In addition, they welcome entries from any school teachers who would like to do this as a class project. So if you're utilizing the FRA program within your club, I encourage you to work with your kids to design posters and send them to **David**. Here are the details:

THEME: "Gemstones of the World." Prepare a poster illustrating one or more gemstones or minerals that interest you, from anywhere in the world.

ELIGIBILITY: 1st through 12th grade. Each grade will have a winner. Ribbons awarded for 1st through 4th place, with the 1st place winner also receiving a prize.

CONTEST RULES:

- · All entries must be presented on paper 12 inches by 18 inches.
- · Include name, address, age and school grade of participant on back of Entry.
- Artwork can be in pen, ink, crayons, magic marker, paint or any other artists' medium.
- No three-dimensional posters accepted.
- · The title may be on the front or the back.
- · List names of the gems and/or minerals and why you chose them.
- · All entries become the property of the Summit Lapidary Club.

SCALE OF POINTS:

Originality & Art Work—30 points; Design—25 points; Title—25 points; Listing of Gems and/or Minerals & Reason Chosen—20 points.

President's Message

Presidents Message:

The combined AFMS/RMFMS Convention and Show in Roswell, New Mexico was an outstanding success. Show Chairman Frank Whitney, Show Advisor Howell Whiting, and all the other members of the Chaparral Rockhounds are to be congratulated. The Editors Breakfast and Awards Banquet were excellent with the best attendance in several years. The AFMS and RMFMS business meetings were also a success despite a few problems with our recording equipment. The show itself had about 130 exhibits with 40 of them being competitive which again are the highest numbers in many years for an AFMS show. There were 10 RMFMS trophies awarded and I believe 19 AFMS trophies. The show had ten quality dealers and the silent auction area had very good materials. The field trips during and after the show were well attended and produced some excellent finds. With all the positives about the show the thing that stood out the most was the hospitality of the Chaparral Rockhounds. I think lists of the winners of the Competitive Trophies will appear elsewhere in this newsletter as will the list of the winners of various bulletin competitions presented at the Editors Breakfast.

New officers elected at the Annual Delegates Meeting are:

President: **Stan Nowak** of the Enid, Oklahoma club.

Vice President: Yonis Lone Eagle of the Farmington, New Mexico club.

Secretary: **Carol Holman** of the Stillwater, Oklahoma club. Treasurer: **Gene Maggard** of the Wichita, Kansas club.

Arizona State Director: **Debbie Leschner** of the Wickenburg, Arizona club. Kansas State Director: **Marvin Lundquist** of the McPherson, Kansas club. North Dakota State Director: **Ray Oliger** of the Bismarck, North Dakota club. South Dakota State Director: **Don Rathert** of the Rapid City, South Dakota club.

The terms of these newly elected officers will begin on Nov. 1, 2007.

Several items of new business were passed at the Annual Delegates Meeting. OP No.

Treasurer—1 was replaced. The new OP gives State Directors up to \$200 for travel expenses relating to their job. It also sets a \$500 maximum reimbursement for travel expenses for RMFMS personnel required to attend AFMS meetings and for the RMF representative to Wildacres. A new OP for the job of Ribbons Chairperson was passed and the requirement that this person be a member of the Uniform Rules Committee was stricken from the Convention Code Management OP. A new OP describing the duties of the Parliamentarian was also passed. The other new OP is one on the RMFMS Trademark; this was to clarify the process of the periodic renewal of the Trademark rights and the use the Trademark. The RMF is a member of the Blue Ribbon Coalition; the new primary contact person will be Ernie Leschner of Wickenburg, Arizona and with our membership one other person in Arizona, Colorado, New Mexico, Utah, and Wyoming will also be receiving information much of which will relate to efforts to keep open roads which we need for collecting opportunities. We also voted a membership for the RMF in the American Lands Access Association, a unit within the AFMS.

FOR IMMEDIATE RELEASE GMUG Proposed Forest Plan Suspended

DELTA, Colorado., May 7, 2007 - Public comment on the Grand Mesa, Uncompangre and Gunnison National Forest (GMUG) proposed Forest Plan is suspended indefinitely. The GMUG proposed Forest Plan was developed under the 2005 Planning Rule and was released for public review on March 16, 2007. On March 30, Judge Phyllis J. Hamilton of the Northern District of California U.S. District Court ruled that the Forest Service's adoption of new planning regulations (2005 Planning Rule) violated the Administrative Procedure Act (APA), National Environmental Policy Act (NEPA), and Endangered Species Act (ESA). Until the Agency complies with the court's order, the Court has enjoined the Forest Service from implementing and utilizing the 2005 Planning Rule.

GMUG Forest Supervisor Charlie Richmond said, "We don't know for sure where we will head with Forest Plan revision in response to the injunction; however, we are evaluating our options for when and how to proceed." He went on to note, "whatever approach, we decide to use, the public collaboration and recommendations we have received to date will be integral in our continuing planning activities. Our stakeholders have helped us develop a vision for the Forest for the next 15-20 years, and we need to prepare effective plans to guide and support that vision."

Some of the options under consideration include: "reinitiating" forest plan revision under the 1982 planning regulations, continuing management under the 1983 Forest Plan and addressing any necessary changes through amendment, waiting for the Agency to make the necessary changes to the 2005 Planning Rule to comply with the Court, and continuing with National Forest Management Act (NFMA) planning activities that are independent of the 2005 Planning Rule (e.g. monitoring, public involvement, scientific analysis, etc).

The work that went into developing the proposed Forest Plan, (e.g. the Comprehensive Evaluation Report (CER) and Comprehensive Assessment) provides information about current conditions, trends, and key findings for the social, economic and ecological components of the Forest. Planning Staff Officer Carmine Lakewood stated, "Regardless of which option(S) we choose, these planning documents, and all the work by our stakeholders, provide valuable information that will be useful in future strategic planning activities, as well as project-level planning efforts."

Apache Tear Polishing Tip

Crushed Walnut Shells are great to use as a filler when polishing Apache Tears. Obsidian is difficult to polish and "bruises" easily. After you have finished filling your tumbler barrels ¾ full of Apache Tears, put in your grit and 3 to 4 cups of crushed walnut shells (you can layer this), then add your water.

The shells can be obtained in 25 lb bags from your local farm/pet supply distributors. You will have to put in fresh walnut shells with each grit but the cost is nominal. Also put shells in with your polishing medium — wash carefully after polishing, but do not run overnight in detergent as you would other rocks. The polish will be great and you won't have any bruising.

Lapping Geodes

When you are trying to polish a geode on a vibrating lap, it is difficult to keep the grit out of the center of the geode when it is hollow and filled with crystals.

One suggestion has been to fill the center with Knox gelatin, a product you can buy at any grocery store. It turns to jelly when mixed with water and after a while, will set up good and firm. Pour this into the geode before polishing and, when you are done, just wash it out with warm water. It leaves no residue.
